### Fuel and Power Purchase Price Adjustment Charges for Licensee Tata Steel Ltd

Fuel and Power Purchase Price Adjustment (FPPPA) Charges are being levied to the consumers of Licensee Tata Steel Ltd on quarterly basis, based on difference of actual and approved power purchase cost.

FPPPA charges relating to Quarter 1 of FY 2019-20 have been calculated by us, and are being charged to the consumers in the electricity consumption bills for the period July-2019 to September-2019.

Adjustment on account of increase in variable cost of power purchased during the period = Rs. 5189.78 lakhs (Rs. 24664.96 lakhs - Rs.19474.96 lakhs).
